CATTLE PROCESSING PLAN:

Possible Point Deductions

Point Deductions:

- Product Name (not complete as it appears on label) (deduct 1 point)

- Route of Administration (Is SQ chose over IM, if injection can be given either way) (deduct 1 point)

- Location of Administration:
 - Two different vaccinations are given in same location (deduct 1 point)
 - Deworming application is inaccurately depicted (deduct ½ point)

- Dose
 - Dosing is incorrect (deduct 1 point)
 - Improper weight is estimated (deduct 1 point per 100 lbs) (deduct 1 point)
 - Implant dosage noted is incorrect (deduct ½ point)
 - Tags – 2 (1 in each ear, if two need to be administered) (deduct ½ point)

- Preslaughter Withdrawal
 - Cell is left blank or information provided is incorrect (deduct 1 point)
 - Ear tag removal information is not listed (deduct ½ point)

<p><u>Respiratory Vaccination Injections (max of 10 pts)</u></p> <p><i>Possible 2 Point deductions to include:</i></p> <ul style="list-style-type: none"> • Failure to re-administer product if not given correctly on first attempt • Shot was given IM instead of SQ • Injection given behind the neck, too high, too low, or too far forward • Needle used to give vaccine is same needle used to draw vaccine out of bottle • Vaccine was not properly hydrated or mixed • Syringe was switched between clostridial and respiratory vaccine • Failure to change cannulas between calves • Improper administration (putting in one nostril, not administering in nostril) <p><i>Possible 1 Point deductions to include:</i></p> <ul style="list-style-type: none"> • Took more than 1 attempt to administer properly • Injection not given where indicated on cattle processing plan • IM injection was given too shallow in the muscle • IM injection was given too low or high on the neck • Wrong dose given (too much or too little) • Needle was dropped or bent <p><i>Other Deductions:</i></p>			
<p><u>Tags (max of 10 pts)</u></p> <p><i>Possible 2 Point deductions to include:</i></p> <ul style="list-style-type: none"> • Tags were handled without gloves <p><i>Possible 1 Point deductions to include:</i></p> <ul style="list-style-type: none"> • Took more than 1 attempt to administer properly • Ear tag not placed in 2 ears per instructions on bag • Ear tag button is in contact with implant • Tag placed in ear backward (unless placed here to avoid blocking visual tag) • Tag not placed in location specified on cattle processing plan • Tag not placed securely or correctly in ear <p><i>Other Deductions:</i></p>

<p><u>Cattle Handling (max of 10 pts)</u> <i>Possible 2 Point deductions (minimum) to include:</i></p> <ul style="list-style-type: none"> • Rough handling • Excessive roughness in moving cattle • Failure to use crowd gate • Excessive use of cattle stick <p><i>Possible 1 Point deductions to include:</i></p> <ul style="list-style-type: none"> • Team had to have more than one attempt to properly load cattle into alley chute • Noisy handling • Missed head • Failure to use squeeze before starting processing • Failure to release squeeze before releasing calf • Failure to latch crowd gate • Failure to use bar behind calves • Failure to remove bar in chute after releasing calf when gate is open for next calf <p><i>Other Deductions:</i></p>			
<p><u>Safety (max of 10 pts)</u> <i>Possible 2 Point deductions (minimum) to include:</i></p> <ul style="list-style-type: none"> • Any action that puts handlers/team at risk • Handler's head too close to the calf's head during tagging or implanting • Attempting to inject in the neck in front of the head catch <p><i>Possible 1 Point deductions to include:</i></p> <ul style="list-style-type: none"> • Dropping the tail gate on the calf <p><i>Other Deductions:</i></p>
